

3. Formulation of Plan

In order to carry out the above activities, detailed plans shall be formulated after consultation between the two colleges from time to time depending on the nature and need of specific activity, availability of funds and convenience of both the colleges. However the basic principle shall be mutual cooperation and benefit of students and faculty members of both the colleges.

4. Financial Terms and mode of payment if any

requirement of funds for these activities/ Programs shall be worked out through mutual consent between the Jamner College and pharmacy college jamner.

The Jamner College and pharmacy college jamner shall not demand any monetary charges from each other for useof technology and know-how developed for their own internal use for the purpose of teaching raining, research and development.

5. Dissemination of data and information

The Jamner College and pharmacy college jamner shall work out the modalities for dissemination of research data of joint research projects to any third party keeping in mind the mutual academic interest. However, both parties shall fulfill their obligation of disseminating the data to national databanks, as required by the concerned funding agencies.

6. Coordination committee

A joint coordination for smooth and effective execution of activities and programmes under this MoU may be formed by mutual consent.

7. reriod of MoU

This Memorandum of Understanding comes into effect from the date of its signing and will remain in force initially for three years. Its validity may be extended by mutual agreement between the two institutions.

8. Revision etc. of MoU

This Memorandum of Understanding may be revised or terminated upon mutual consultation between the two institutions.

9. Non-exclusive Nature

This MoU between the Jamner College and pharmacy college jamner is and shall be non-exclusive in its nature for both the parties and shall not come in then way of either partner from collaboration with the third party.
